This letter outlines your 2019 Mission Share (apportionment), Mission Agency Support, and District Mission Share (if your district has established one).

**Mission Share**

- The mission share formula is based on a 10% tithe of each church’s total operating income.
- The 2019 Mission Share is based on the 2017 total operating income, \$21,982, which is the amount listed on Table 3, line 52, of your church’s annual report to the conference.

**Mission Agency Support**

- Each local church also will be asked to contribute an amount equal to 1% of its 2017 total operating income as reported on Table 3, line 52 (\$21,982) to the mission work of key partner agencies. These agencies are separately incorporated and have a historic missional tie to the work of the conference.
- Money given to Mission Agency Support will be divided proportionately among the agencies.

**Gateway District Mission Share:**

- Any district that wishes to assess its member churches a mission share for district projects can do so by vote of the District Conference. Each district also determines the formula by which those shares are distributed.
- In the Gateway District, your district mission share is set at \$2.50 per member as reported in your 2017 year-end statistics.
